ADOPTED AMENDMENT TO THE ARTICLES OF INCORPORATION OF
CHEVAL PROPERTY OWNERS' ASSOCIATION, INC.

1. Adopted amendment to Article VII, of the Articles of Incorporation, as follows:

## ARTICLE VII

## **BOARD OF DIRECTORS**

The affairs of the Association shall be managed by a board of Directors initially composed of three (3) Directors, who need not must be members of the Association, and be in good standing in Cheval East. The number of Directors may be changed by amendment to the By-Laws of this Association but shall never be less than three (3). The term of office for all Directors shall be one (1) year. The names and addresses of the persons who are to act in the capacity of Directors until their successors are elected and qualify, unless they sooner shall die, resign, terminate their membership in the Association, or are removed, are: . . .

2. Adopted amendment to Article VIII, of the Articles of Incorporation, as follows:

The names and addresses of the officers of this Association who, subject to these Articles of Incorporation and the By-Laws of this Association and the laws of the State of Florida, shall hold office for the first year of the existence of this Association, or until an election is held by the Directors of this Association for the election of officers following the first annual members meeting, if earlier, and until their successors have been duly elected and qualify, unless they sooner die, resign, terminate their membership in the Association, or are removed, are:...

Thereafter, officers shall be elected at the Board of Directors meeting next following each annual meeting of members. Officers need not must be members of the Association, and be in good standing in Cheval East.
